Instructions and other information relating to e-voting are as under:

- 1. Launch internet browser by typing the URL: https://evoting.karvy.com.
- 2. Enter the login credentials (i.e. User ID and password mentioned overleaf). Your Folio No./DP ID/ Client ID will be your User ID. However, if you are already registered with Karvy for e-voting, you can use your existing User ID and password for casting your vote. If required, please visit https://evoting.karvy.com for your existing password.
- 3. After entering these details appropriately, click on "LOGIN".
- 4. You will now reach password change Menu wherein you are required to mandatorily change your password. The new password shall comprise of minimum 8 characters with at least one upper case (A-Z), one lower case (a-z), one numeric (0-9) and a special character (@,#,\$,etc.).
