## Instructions and other information relating to e-voting are as under:

- 1. Launch internet browser by typing the URL: https://evoting.karvy.com.
- 2. Enter the login credentials (i.e. User ID and password mentioned overleaf). Your Folio No./DP ID/ Client ID will be your User ID.
